

## **DISCIPLINARY SYSTEM – MERITS AND DEMERITS**

### **PREAMBLE**

The School will apply all due diligence to ensure that no learner is given a demerit or placed on detention unnecessarily or unfairly. We understand he inconveniences detention causes parents, and also supervising educators and prefects who need to rest at the end of a hard week. Therefore the last thing we would want to do is detain learners for no good reason.

In this regards, we appreciate all the cooperation and understanding that parents can afford us around detention, for the sake of discipline and good education in the school.

Demerit and Detention Procedure will be as follows:

- Teachers to enter weekly demerits on SA SAMS by the end of day every Friday.
- Discipline Committee will total demerit points for week.
- Students achieving a total of 7 demerits for the week, or as accumulation from other weeks, will receive Detention Notices during Register class period, or any other time, on Monday.
- Learners will take the Detention Notices home for parents/ guardians for signing. Parents will also be notified by email and SMS to ensure sufficient communication.
- Learners must return signed Detention Notices to the Detention Supervisor directly before or during first break the next day, which is Tuesday.
- The notice period from Monday to Friday is meant to give parents/guardians sufficient time to
  organize or reschedule transport for their children as normal Friday school day ends at 14h45
  and school buses leave promptly, and also appeal against the detention should they wish. The
  school will not take responsibility, and will not be held accountable, for transport arrangements
  of learners after detention.
- Learners, through their parents/guardians, reserve the right to appeal detention. The appeal process is outlined in this policy document.
- Detention starts at 14h45 and ends 16h00 on Friday, and no learners will be released before 16h00. Should a learner/s leave before 16h00, for whatever reason, they automatically will be rescheduled to retake the detention the next Friday, or assigned day.
- Detention will be supervised by assigned Discipline Committee Members and prefects.
- Should the Disciplinary Committee change the day due to unforeseen circumstances, learners and parents will be notified at least 3 working days in advance.
- Learners will be assigned writing tasks during detention, either copying lines from the School prospectus or dictionary sections.
- Detention will not be used as an opportunity to complete homework or personal tasks.

- Detention supervisors will monitor learner's engagement with assigned tasks and should learners fail to apply themselves fully to such tasks, or are not cooperative, a demerit will be issued.
- Detention will be run under examination conditions, where all forms of communication, cell phones and tablets and ear phone are prohibited.
- Unauthorized people will not be allowed into the detention venue, under any circumstances, for the safety of the learners and educators, and smooth running of sessions.
- Wednesday is the cutoff date for any excuses or appeal processes with regards to the weekly detention.
- Should a learner miss detention without a valid, acceptable reason, they will be penalized with TWO consecutive detentions.
- Missing detention twice without valid, acceptable reasons will result in a disciplinary hearing involving parents/guardians, and double detention for each missed session.

#### **Detention Appeal Process**

- Parents must notify the Head of Discipline, in writing, about their wish to appeal and the
  reason/s for the appeal, before or by end of first break, 10h40, on Tuesday following the
  Monday of issue of notice for detention. A section is reserved on the Detention Notice letter for
  any appeal.
- 2. The Head of Discipline, or any assigned member of the Discipline Committee, will respond to the appeal and a letter will be handed to the learner to take home.
- 3. In the event that parents/guardians are not satisfied by the outcome of the appeal, a second appeal must be delivered to the Head of Discipline in writing before end of first break, 10h40, the next day, Wednesday. Automatically a meeting will be scheduled with the parent/guardian. Head of Discipline or assigned member of Discipline Committee, grade head for the learner's grade, and the educator/s concerned. The meeting will strictly be scheduled between 14h30 and 15h30 on the Wednesday.
- 4. If parents/guardians are still not satisfied with the outcome of the meeting, they have the right to immediately see the Principal.
- 5. After Wednesday, no excuses will be tolerated, except in cases of emergency. All appeal processes will end by end of day Wednesday, unless the Principal instructs otherwise.

#### **Merits**

Merit procedure will be as follows:

- Teachers to enter on SA SAMS and email to the Vice-Principal every Friday.
- 2. Ethics Committee will total merit points.
- 3. Students achieving a total of 7 merits points will receive certificates at the School's formal Friday assemblies. (Certificates will feature their reasons for merits.)
- 4. Their names will be announced by the Principal, and they will walk up on the podium to receive their certificate.
- 5. Certificates will be taken home to parents, as proof of award.
